Fees and calculations

This information is in accordance with the Chamber's Memorandum and Articles of Association.

1.Subscriptions to the Chamber are payable in advance and within the terms stated in the invoice issued by the BRCC accounts department

2.In order to cancel BRCC membership, at least 30 days' notice is required prior to the expiry due date.

3. Notice received after the expiry/renewal date will be subject to a pro rata fee for the period between renewal and cancellation.

- 4.The management of the Chamber reserves the right to amend the fee structure if and when required. Due notice will be given to members.
- 5.Members shall not be entitled to any of the benefits and privileges of membership so long as their subscription remains unpaid.
- 6.A member shall cease to be a member of the Chamber if their subscription or any other fees due to the Chamber remains in arrears for a period exceeding three months.
- 7.A member shall cease to be a member of the Chamber if a Receiving Order or an adjudication in bankruptcy is made against them or if the member (be- ing a company) goes into voluntary or compulsory liquidation, or is otherwise unable to pay its debts
- 8.A member shall cease to be a member if, in accordance with the Statutes of the Chamber, the member has been guilty of conduct that is dishonourable or prejudicial to the interests of the Chamber, or has willfully acted in contravention of the Articles or any Rules of the Chamber.
