


About us

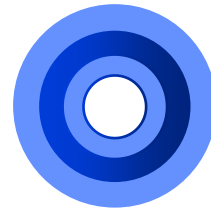

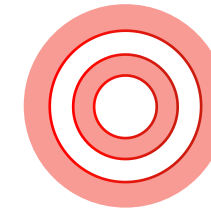
